Rulemaking Activities Being Discontinued by the NRC: Parts 20, 26, 32, 40, 50, 53, 73, 74, and 150 of Title 10 of the Code of Federal Regulations [NRC-1999-0002, NRC-2001-0012, NRC-2002-0013, NRC-2006-0008, NRC-2008-0200, NRC-2009-0227, and NRC-2009-0079; Regulation Identifier Numbers 3150-AH18, 3150-AG89, 3150-AG64, 3150-AH81, 3150-AI29; 3150-AI68, and 3150-AI50]

On July 29, 2016, the NRC published a document in the *Federal Register* ([81 FR 49863](#)) discontinuing eight rulemaking activities. The purpose of this action is to inform members of the public that these rulemaking activities are being discontinued and to provide a brief discussion of the NRC's decision to discontinue them. These rulemaking activities will no longer be reported in the NRC's portion of the Unified Agenda of Regulatory and Deregulatory Actions. The rulemaking activities discussed in this document are discontinued effective July 29, 2016.
