Task Order 3, Entitled "North Carolina State University Safety Evaluation Input Development for Fueled Experiment License Amendment" under EnterpriseWide Contract No. NRC-HQ-25-14-E-0006.

The purpose of this modification is to revise the statement of work (SOW) to increase the level of effort for existing tasks 1, 2, and 3, incorporate optional sub-task 3b, which can only be exercised via a later modification to the task order, and extend the period of performance through December 30, 2016. As a result, the exercised ceiling is increased by \$42,966.00 from \$80,648.00 to \$123,614.00, and funds are obligated in the amount of \$42,966.00, which increases the total obligations from \$80,648.00 to \$123,614.00.
