This materials license authorizes the distribution of processed topaz containing byproduct materials to persons exempt from licensing pursuant to Section 30.14, 10 CFR Part 30, or equivalent provisions of the regulations of any Agreement State.

The last shipment of processed topaz was completed in September 2011. In addition, no material was ever possessed under this license (all material possession was authorized by our New Hampshire license # 381R and our Texas license # L06189).

CERTIFICATE OF DISPOSITION OF MATERIALS
