This refers to your license amendment request dated June 16, 2016. Please find enclosed Amendment No. 65 which removes Maloney Hall as a location of use under your license. Maloney Hall may be released for unrestricted use.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(20).
