Status of Recommendations

Recommendation 1:

Require license reviewers to write radiography licenses in a manner that clearly and consistently specifies whether or not licensees are authorized to conduct certain activities (such as offshore, lay-barge, or underwater radiography).

**Agency Response Dated
August 3, 2016:**

In your memorandum dated February 3, 2016, to Victor M. McCree, Executive Director for Operations, it states that OIG will consider this recommendation closed when the agency provides a copy of the revised (issued) version of NUREG-1556 Volume 2, "Consolidated Guidance About Materials Licenses: Program-Specific Guidance About Industrial Radiography Licenses," and a copy of the procedure that includes the standardized license conditions and authorized uses. The electronic copy of NUREG-1556 Volume 2, Revision 1, can be found in NRC's Agencywide Documents Access and Management System (ADAMS) under Accession Number ML16062A091 and the copy of the procedure (version dated May 2016) that includes the standardized license conditions and authorized uses can be found in ADAMS under Accession Number ML16196A358. The staff recommends that Recommendation 1 be closed.

OIG analysis:

OIG reviewed the completed (issued) revised version of NUREG-1556 Volume 2, and the procedure that includes the standardized license conditions and authorized users. This recommendation is now closed.
