

**SAFETY EVALUATION REPORT  
PROPOSED CHANGE OF CONTROL FOR BYPRODUCT MATERIALS LICENSE**

**SUMMARY AND CONCLUSIONS:**

Inspecsol Engineering Inc. ("the licensee") is authorized by NRC License 21-32548-01 for the possession and use of byproduct material. The licensee is a wholly owned subsidiary of Conestoga-Rovers & Associates, Inc., of which CRA Holdings Inc. ("the transferor") owns 100 percent of shares. The U.S. Nuclear Regulatory Commission (NRC) staff reviewed a request for consent to a direct license transfer submitted by the licensee that would result from the acquisition of the transferor by GHD Holdings (Canada) Inc. ("the transferee"). As a result of the acquisition, the transferee would be the owner of the CRA Holdings Inc., which owns Conestoga-Rovers & Associates, Inc., which owns the licensee. Finally, as part of a rebranding effort, Conestoga-Rovers & Associates, Inc. would undergo a name change to GHD Services Inc., and ultimately be listed as the licensee. The direct transfer of control is described in the June 17, 2016 request letter (Agency Documents Access and Management System (ADAMS) accession number ML16172A041). A publicly available version of the request was received in a June 28, 2016 letter (ADAMS accession number ML16180A095).

The request for consent was reviewed by NRC staff for a direct change in control of a Title 10 *Code of Federal Regulations* (CFR) Part 30 license using the guidance in NUREG 1556, Volume 15, "Consolidated Guidance About Materials Licenses - Guidance About Changes of Control and About Bankruptcy Involving Byproduct, Source, or Special Nuclear Materials Licenses," revision 1, dated June 2016. The NRC staff finds that the information submitted by the licensee sufficiently describes and documents the transaction and commitments made by the licensee, the transferor, and the transferee.

As required by 10 CFR 30.34 and Section 184 of the Atomic Energy Act of 1954, as amended (the Act), NRC staff has reviewed the application and finds that the proposed change in control is in accordance with the Act. The staff finds that, after the change of control, the licensee will remain qualified to use byproduct material for the purpose requested, and will continue to have the equipment, facilities, and procedures needed to protect public health and safety, and to promote the security of licensed material.

**SAFETY AND SECURITY REVIEW**

According to data obtained from the NRC's Web Based Licensing (WBL) System, the licensee has held an NRC license since December 13, 2004. The NRC most recently conducted inspections of the licensee on October 11, 2005, and October 12 through November 1, 2010, and identified no violations during those inspections, with the exception of two Department of Transportation (DOT) – 10 CFR Part 49 – Severity Level IV violations.

The NRC also initiated an inspection on October 2, 2015; that inspection is currently open and review is ongoing. In the licensee's request for NRC consent to the indirect transfer of control, commitments made by the transferee and the transferor state that the licensee:

- A. other than a change to the Radiation Safety Officer (RSO), will not change the personnel authorized in the NRC license;
- B. will not change the organization, locations, facilities, equipment, or procedures authorized in the NRC license;
- C. will not change the radiation safety program authorized in the NRC license; and
- D. will keep regulatory required surveillance records and decommissioning records.

GHD Services Inc. holds a Michigan business license for operations within the scope of proposed licensed activities. Accordingly, the transferee is considered a known entity following the guidance provided by the NRC's Office of Federal and State Materials and Environmental Management Programs (FSME) "Checklist to provide a basis for confidence that radioactive materials will be used as specified on the license," September 3, 2008 revision. The purpose of this checklist is for the NRC to obtain reasonable assurance from new license applicants or NRC licensees transferring control of licensed activities that the licensed material will be used for its intended purpose and not for malevolent use.

The licensee is not required to have decommissioning financial assurance based on the types and amount of material authorized by License No. 21-32548-01.

## **REGULATORY FRAMEWORK**

License No. 21-32548-01, was issued under 10 CFR Part 30, Rules of General Applicability to Domestic Licensing of Byproduct Material. Under 10 CFR 30.34(b), for licenses "issued or granted pursuant to the regulations in [Parts 30] through 36," the Commission is required to determine if the change of control is in accordance with the provisions of the Act, and give its consent in writing. Specifically, no 10 CFR Part 30 licenses, "nor any right under a license shall be transferred, assigned or in any manner disposed of, either voluntarily or involuntarily, directly or indirectly, through transfer of control of any license to any person, unless the Commission shall, after securing full information, find that the transfer is in accordance with the provisions of the Act and shall give its consent in writing." The review was completed in accordance with NUREG 1556, Volume 15, revision 1, and informed by 63 *Federal Register* 66721, "10 CFR Parts 2 and 51, RIN 3150-AG09, Streamlined Hearing Process for NRC Approval of License Transfers, Nuclear Regulatory Commission, Final Rule," dated Dec. 3, 1998.

## **DESCRIPTION OF TRANSACTION**

In letter dated June 17, 2016, Inspecsol Engineering Inc. ("the licensee"), CRA Holdings Inc. ("the transferor"), and GHD Holdings (Canada) Inc. ("the transferee"), notified the U.S. Nuclear Regulatory Commission that the transferee, via a direct transfer, planned to acquire 100 percent of the transferor's assets, including those of the licensee and the licensee's parent company Conestoga-Rovers & Associates, Inc.

The transaction is described in ADAMS accession number ML16172A041. After completion of the acquisition, the licensee would continue as the owner of all licensed activities authorized under NRC Materials License No. 21-32548-01, with no significant changes to key responsible personnel (other than the RSO), licensed facilities, or equipment.

The NRC staff finds that the request for consent adequately provides a complete and clear description of the transaction, and is consistent with the guidance provided in NUREG-1556, Volume 15, revision 1, Appendix E, "Information Needed for Transfer of Control."

#### **THE TRANSFEREE'S COMMITMENT TO ABIDE BY THE TRANSFEROR'S COMMITMENTS**

The NRC staff finds that the commitments and information submitted by Inspecsol Engineering Inc., CRA Holdings Inc., and GHD Holdings (Canada) Inc., under letter dated June 17, 2016 (ML16172A041), are consistent with the guidance outlined in NUREG-1556, Volume 15, revision 1.

#### **ENVIRONMENTAL REVIEW**

An environmental assessment for this action is not required since this action is categorically excluded under 10 CFR 51.22(c)(21).

#### **CONCLUSION**

The staff has reviewed the request for consent submitted by both parties with regard to an indirect change of control of byproduct materials license No. 21-32548-01 and approves the application pursuant to 10 CFR 30.34(b).

Submitted information sufficiently describes the transaction; documents the understanding of the license and commitments; demonstrates that personnel have the experience and training to properly implement and maintain the license and that they will maintain the existing records; And, in the future, will abide by all existing commitments to the license, consistent with the guidance in NUREG-1556, Volume 15, revision 1.

In accordance with the above analysis, the staff concludes that the proposed change in control would not alter previous findings, that licensed operations will not be inimical to the common defense and security, or to the health and safety of the public.
