Discussion: Mr. Mazza was called to request additional information in order to complete the review of the amendment request submitted, dtd Aug. 1, 2016 (letter not publicly-available; contains security-related information). I informed the owner that we need the following information to complete our review:

1. Manufacturer and Model Nos. of the sealed sources and devices requested.
2. Activity and radioisotopes requested for No. 1 above;
3. Quantity of gauges the licensee expects to possess;
4. Serial Nos. of the gauges the licensee intends to acquire under the license;
5. Name of the licensee the gauges will be acquired from;
6. Confirm the address provided as additional storage location to be added to the license. The storage location (field office) requested in the letter is already authorized on the license.

Additionally, I informed the owner that the Seaman Nuclear Corporation (SNC) gauges containing radium-226 require a different shipping label and shipping papers than other nuclear gauges. I informed him to ensure the shipping papers/markings/labels are correct by visiting the SNC website. I also informed him of the leak test frequency for the SNC gauges. He said he understood and that he would contact his consultant, David Rhoe, and ask Mr. Rhoe to provide the additional information. Mr. Mazza said he would call me with the information.
