This refers to your license amendment request dated June 29, 2016. Please find enclosed Amendment No. 25 to change the building number of your Rawlins Drive location of use from 200 to 100. We understand that this was not a physical move and only the number designation changed.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
