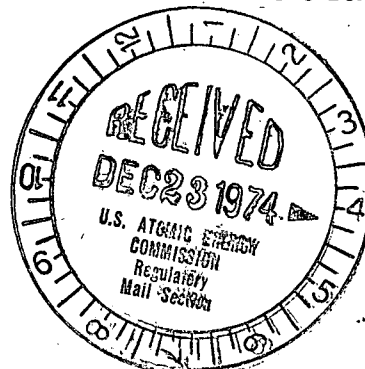
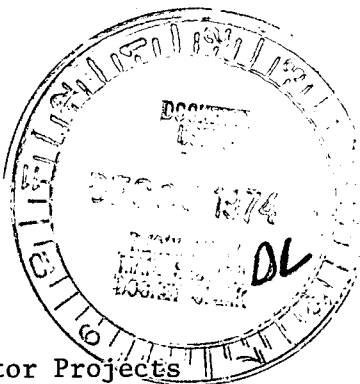

Dear Mr. Giambusso:

On December 12, 1974, six of the 24 condenser cooling water screens at the Oconee Nuclear Station were inspected in place by divers. A total of 631 small fingerling fish had collected on the screens. The fish were categorized, where possible, as to screen location, type and size. This information is tabulated in Enclosure 1. The mortality of these 631 fish had an insignificant effect on the fisheries resources in Lake Keowee.
