This letter serves to notify the NRC of a possible "change of control" of specifically and generally licensed radioactive materials presently licensed by CONSOL of Kentucky Inc. under License #47-25168-01. Based on an anticipated asset purchase, Southeastern Land, LLC will acquire certain assets of CONSOL of Kentucky Inc. including its Tug Valley Preparation Plant located near Naugatuck, West Virginia.

Based on Sections 5.1 through 5.6 of NUREG-1556, Vol. 15 (Guidance About Changes of Control and About Bankruptcy Involving Byproduct, Source, or Special Nuclear Materials Licenses) specific information relative to U.S. NRC License #47-25168-01 follows.

Section 5.1 (Description of Transaction)

- It is the intent of Southeastern Land, LLC to acquire certain assets of CONSOL of Kentucky Inc. including its Tug Valley Preparation Plant located near Naugatuck, West Virginia through an asset purchase.

#### Section 5.2 (Changes of Personnel)

- Marvin E. Daniels, the current RSO, is anticipated to remain the RSO for Southeastern Land, LLC. Individuals responsible for radiation safety and or authorized to use licensed material are also not anticipated to change. Southeastern Land, LLC will promptly update its license should any changes to the RSO or authorized individuals occur.

#### Section 5.3 (Changes of Location, Equipment & Procedures)

- No change in personnel, who now exercise control over the current licensed program, is anticipated. No change in the licensed material location, use, or facility equipment as it may affect program safety, or procedures (i.e., operating or emergency procedures) are planned.

#### Section 5.4 (Surveillance Records)

- All required, applicable surveillance items including a physical inventory and leak tests will be current at the time of acquisition.

#### Section 5.5 (Decommissioning and Related Records Transfers)

- All surveillance and other required license records will remain with and continue to be maintained by the RSO.
- As evidenced by leak test documents, no contamination has been identified in association with licensed devices and sources.
- Decommissioning of any device or location associated with this license is not planned at this time.




