U.S. Nuclear Regulatory Commission:

This is to request an amendment to change location of use for Island Heart Care, license number 53-35099-01.

1. Island Heart Care is moving location from 75-167 Hualalai Road, Kailua Kona, Hawaii 96740 to 75-1027 Henry Street #110, Kailua Kona, Hawaii 96740.
2. Attached is a diagram of the new location. Radioactive materials will be used in the rooms labeled "Hot Lab", "Nuc", and "Stress Echo". No other rooms will be used for radioactive materials. The door to the hot lab will be locked whenever authorized individuals are away from the area. This door will be posted with a radiation warning sign, emergency procedures, and emergency contact information for the Radiation Safety Officer.
3. A Final Status Survey (FSS) will be submitted upon final use at location: 75-167 Hualalai Road, Kailua Kona, Hawaii 96740 in accordance with 10 CFR Part 30.36.
4. The authorized users and Radiation Safety Officer will remain the same as in the current license. All radiation safety procedures as specified in the current license will remain in effect for this new site.
