Order Approving Indirect Transfer of an Export License

I.

Reviss Services, Inc. (“Reviss” or “the Licensee”) holds export license no. PXB16.07.

II.

By letter dated September 19, 2016 (Agencywide Documents Access and Management System [ADAMS] Accession Number ML16264A101) submitted by Sterigenics International, LLC, the U.S. Nuclear Regulatory Commission (NRC) was notified of the proposed indirect transfer of control of export license PXB16.07 (ML11290A037). The letter supplements an earlier proposed indirect transfer of control dated August 18, 2016, (ADAMS Number ML16235A028) submitted by REVISS Services United Kingdom (UK) that mischaracterized the post-transfer ownership organizational chart.

The indirect transfer will occur as a result of REVISS Services, Limited, a Cyprus company, selling all of its shares in REVISS Services (UK) Limited, a UK company (“REVISS UK”), to STR 2 BV, a Dutch wholly-owned subsidiary of Nordion (Canada) Inc., a Canadian company, (“Nordion”). REVISS UK is the parent company of REVISS Services, Inc., an Illinois company (“the Licensee”). Following the closing of the transaction, the Licensee would remain

a wholly-owned subsidiary of REVISS UK, REVISS UK would become a sister company of Nordion (Canada) Inc. (“Nordion”), and both REVISS Services and Nordion would be subsidiaries of STR 2 BV. Thus, the proposed transaction would result in an indirect transfer of control over the Licensee. The stock purchase agreement was executed with both parties on August 15, 2016.

Sterigenics International, LLC and REVISS UK requested approval of the indirect transfer of the licenses pursuant to Section 184 of the Atomic Energy Act of 1954, as amended (AEA) (42 U.S.C. § 2234) and Title 10 of the *Code of Federal Regulations* (10 CFR) 110.50(d). The letter from Sterigenics International, LLC requesting NRC approval of the transfer was made publicly available in ADAMS on September 19, 2016. No requests for hearing or comments were received. The letter from REVISS (UK) Limited requesting NRC approval of the transfer was made publicly available in ADAMS on August 18, 2016. No requests for hearing or comments were received. Pursuant to Section 184 of the AEA, no license granted under 10 CFR part 110 shall be transferred, assigned, or in any manner disposed of, directly or indirectly, through transfer of control of any license to any person unless the Commission, after securing full information, finds that the transfer is in accordance with the provisions of the AEA, and gives its consent in writing.

The staff finds that the information submitted by Sterigenics International, LLC and REVISS (UK) Limited sufficiently describes and documents the transactions and commitments made by Sterigenics International, LLC. REVISS Services, Inc. will remain the licensee. There are no planned changes in the licensed program and no amendments to the license. No physical changes to the REVISS source facility or operational changes are being proposed in the application. Upon review of the information received from Sterigenics International, LLC and REVISS (UK) limited, and relying upon the representations and agreements contained in the

Transfer Application, the NRC staff finds that the corporate restructuring that will ultimately result in the sale of shares of REVISS UK to STR 2 BV, a Dutch wholly-owned subsidiary of Nordion (Canada) Inc., is otherwise consistent with applicable provisions of laws, regulations and orders issued by the Commission pursuant thereto. The staff finds that REVISS Services, Inc. will remain qualified to hold the Part 110 license for the purpose requested and will continue to have the equipment, facilities, and procedures necessary to protect public health and safety and promote the common defense and security.

Accordingly, pursuant to Section 184 of the AEA Act of 1954, as amended, IT IS HEREBY ORDERED that the indirect transfer of license of Reviss Services, Inc., as described herein, is approved.

IT IS FURTHER ORDERED that after receipt of all required regulatory approvals of the proposed indirect transfer, STR 2 BV, as the parent company, shall inform the Director of the Office of International Programs, in writing, of such receipt no later than one (1) business day prior to the closing of the proposed indirect transfer. Should the proposed indirect transfer not be completed within 60 days from the date of issuance of this Order, the Order shall become null and void; however, on written application and for good cause shown, such date may be extended by order.

This Order is effective upon issuance.
