By the letter dated May 24, 2016, Molecular NeuroImaging requested written consent by the U.S. Nuclear Regulatory Commission (NRC) to a proposed direct transfer of control of the above license to inviCRO, LLC. From your letter, we understand that this transfer will not result in any change to the licensed name, location of use, materials, persons using licensed material, or persons responsible for radiation safety at the licensed facility.

Based on the above understandings, as more fully detailed in the enclosed NRC staff's Safety Evaluation Report, which documents the NRC staff's safety review of the request, the NRC consents to the proposed direct transfer of control of NRC Materials License No. 06-30624-01.
