SUBJECT: DELEGATION OF AUTHORITY FOR CERTAIN ENFORCEMENT
ACTIONS TO THE EXPORT CONTROLS AND
NONPROLIFERATION BRANCH CHIEF

By memorandum dated May 4, 2016, (Agencywide Document Access and Management System Accession No. ML16116A349), the Director, Office of Enforcement (OE) delegated authority for certain enforcement actions to the Director, Office of International Programs (OIP). The Director, OIP, may further delegate certain authorities, subject to the requirements and limitations listed therein.

The Chief, Export Controls and Nonproliferation Branch (ECNP), is hereby delegated the authority to approve, sign, and issue certain enforcement actions. This delegation applies to enforcement actions in all areas in which OIP evaluates, manages, or inspects.

The Branch Chief, ECNP, is hereby authorized to take the following actions:

1. With OE concurrence, approve, sign, and issue nonescalated enforcement actions and enforcement related letters to licensees, certificate holders, applicants, vendors, and nonlicensees (other than vendors). For the purpose of this memorandum, nonescalated enforcement actions refer to Severity Level IV, noncited and minor violations, Notices of Deviation, and Notices of Nonconformance.
2. With OE concurrences, approve, sign, and issue enforcement discretion for nonescalated enforcement actions.

The Director, OIP, as provided in memorandum dated May 4, 2016, will not delegate the authority to approve, sign and issue responses to disputed nonescalated enforcement actions as well as sign and issue actions to modify, withdraw or rescind violations after issuance. OE must concur prior to issuance.
