Dear Mr. Burch:

This letter refers to the onsite inspection conducted from August 8 – 11, 2016, at your Mt. Athos facility located in Lynchburg, VA. The purpose of the inspection was to determine whether activities authorized by the license were conducted safely and in accordance with the U.S. Nuclear Regulatory Commission's (NRC) requirements. At the conclusion of the onsite inspection, the findings were discussed with members of your staff.

Areas examined during the inspection included access controls for material, personnel, and vehicles; protected area detection systems; information protection programs for protecting safeguards and classified information; and a follow-up on a previously identified issue. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress.

Based on the results of the inspection, the NRC has determined that a Severity Level (SL) IV Violation of NRC requirements was identified. Because BWXT NOG, Inc., identified the issue, initiated a corrective action report and took appropriate corrective actions, this violation is being treated as a Non-Cited Violation (NCV), consistent with Section 2.3.2 of the Enforcement Policy. The NCV is described in the subject inspection report. If you contest the violation or significance of the NCV, you should provide a response within 30 days of the date of this inspection report, with the basis for your denial, to the Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington DC 20555-0001, with copies to: (1) the Regional Administrator, Region II; (2) the Director, Office of Enforcement, United States Nuclear Regulatory Commission, Washington, DC 20555-0001; and (3) the resident inspector at your BWXT NOG facility.

The enclosure contains Sensitive Unclassified Non Safeguards Information (Security-Related Information). Upon separation, this cover letter is DECONTROLLED.
