**RE: Confirmation of Corporate Restructuring**


Dear Ms. Pelke:

By letter dated June 10, 2016, I notified the Nuclear Regulatory Commission (NRC) that on or about July 29, 2016, Mallinckrodt plc planned to complete an internal corporate reorganization that would result in a change to the immediate corporate parent of NRC licenseholder Mallinckrodt Nuclear Medicine LLC (License Nos. 24-04206-01, 24-04206-02, and 24-04206-05MD). I provided a description of the planned legal entity moves and sought NRC's concurrence that the moves did not constitute a change of control pursuant to 10 CFR § 30.34(b).

By letter dated July 28, 2016, NRC confirmed that the legal entity moves did not constitute a change of control. The letter directed me to notify you "within 30 days, in writing, after the transaction has been finalized and include information to support other necessary changes such as a facility name change." By this letter I am notifying you that the planned changes described in my June 10, 2016, letter became effective on August 22, 2016. No other changes are occurring at this time, including a facility name change.

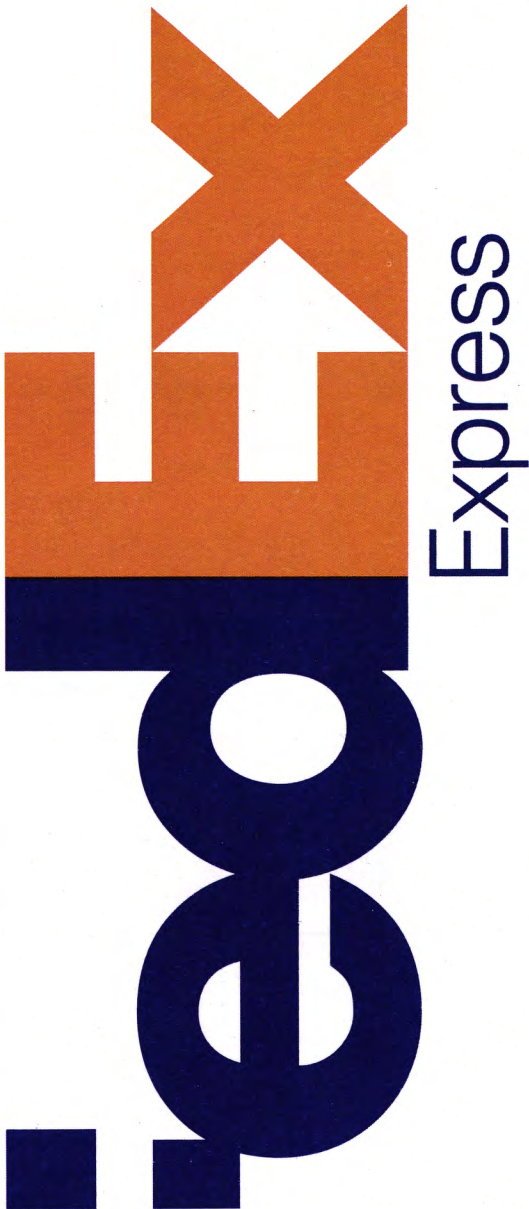

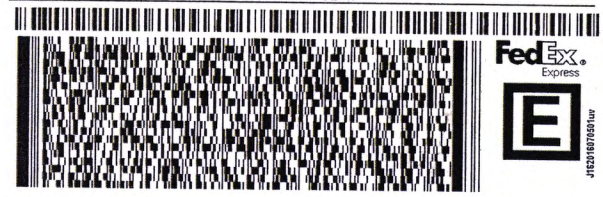

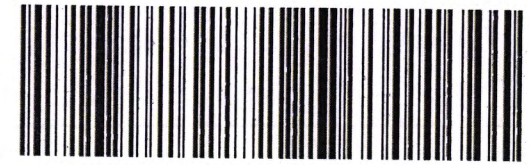
