

14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to increase the level of effort for Task 4, Support for Licensing Proceeding and Litigation, by 120 hours to accommodate for additional contractor support, and to change the Contracting Officer's Representative (COR) from Mirabelle Shoemaker to Jesse Muir-Quintero. This additional contract support is due to delays caused by the Atomic Safety and Licensing Board Panel hearing schedule.

As a result, (1) the total estimated cost plus fee of this task order is increased by \$22,173.00 from \$331,429.00 to \$353,602.00, (2) funds in the amount of \$22,173.00 are hereby obligated to this task order, and (3) Ms. Mirabelle Shoemaker is hereby replaced as the COR by Ms. Jesse Muir-Quintero.
