Enclosed is Amendment No. 5 renewing your NRC Material License No. 24-32615-01 in accordance with your request. Your license has been renewed for a term of ten years and will not expire until August 31, 2026.

At this time, we also deleted Condition No. 13, as it appeared on Amendment No. 04, in favor of adding reference to 10 CFR Part 71 in the Preamble language at the top of page 1 of your license. We also added ADAMS accession numbers to the documents listed in Condition No. 14.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

**In correspondence dated March 28, 2016, and August 15, 2016, you requested the release for unrestricted use of your former location of use located at 1100 W. 10<sup>th</sup> Street, Suite 155, Rolla, Missouri. The NRC staff has reviewed your final status surveys.**

**Based on its review, the staff has concluded that all licensable radioactive material has been removed from this former location of use and residual radioactive material attributable to licensed activities does not exceed current NRC criteria. Based on these conclusions no further remediation or actions with respect to NRC regulated material is required for this former location of use and it is suitable for unrestricted use.**

Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
