The purpose of this modification is to

1) Exercise Option Year Three (3) in the amount of \$236,268.14, thereby increasing the exercised ceiling amount from \$655,665.61 to \$891,933.75 and extending the period of performance through 09/30/2017.

2) Provide incremental funding in the amount of \$140,700.00, thereby increasing the total obligated amount from \$490,041.00 to \$630,741.00.

3) Revise Section B.3 titled "Detailed Cost Estimate" to include a 3rd option year in the amount of \$236,268.14, that was inadvertently omitted from the original contract award document.
