Please find enclosed Amendment No. 7 authorizing additional cesium-137, and americium-241/beryllium and authorizing Seaman Nuclear Corporation Models C-200 and C-300 gauges containing radium-226, as requested in your amendment request. Also, please note that the page layout and format has changed from the previous amendment.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
