AMENDMENT AND GRANTING OF EXEMPTION RE: TIER 1 EDITORIAL AND
CONSISTENCY CHANGES (TAC NO. RT5007)

Dear Mr. Whitley:

In response to your application dated June 3, 2016, the U.S. Nuclear Regulatory Commission has granted the enclosed Exemption and issued the enclosed Amendment No. 56 to Combined Licenses Nos. NPF-91 and NPF-92 for the Vogtle Electric Generating Plant (VEGP), Units 3 and 4, respectively. The amendment consists of changes to the Updated Final Safety Analysis Report (UFSAR), plant-specific Tier 1 information, with corresponding changes to Appendix C of the Facility Combined Licenses (COL), and COL paragraph 2.D.(12)(g)1.

The amendment authorizes changes in the UFSAR. The exemption allows various changes to correct editorial errors in Tier 1 and promote consistency with the UFSAR Tier 2 information. The proposed changes impact Tier 1 of the Plant-Specific Design Control Document, with corresponding changes to Appendix C of the COL, as specified in License Amendment Request 16-008. This exemption is related to, and necessary for the granting of License Amendment No. 56, which is being issued concurrently with this exemption.
