**Joseph M. Farley Nuclear Plant  
Registration of Previously Loaded Spent Fuel Casks  
In accordance with Conditions of HI-STORM 100 CoC 1014, Amendment 9, Rev. 1**

Ladies and Gentlemen:


On January 6, 2016 the NRC published a final rule amending the Holtec HI-STORM 100 Certificate of Compliance (CoC) 1014 as Amendment 9, Revision 1 (9R1) which became effective on March 21, 2016 and must be implemented by September 17, 2016. Condition 13 of CoC 1014, 9R1 required general licensees to perform written evaluations in accordance with 10 CFR 72.212 to apply the changes authorized by the revised certificate to previously loaded casks and then to re-register the casks within 30 days.

Southern Nuclear Operating Company (SNC) operates the Joseph M. Farley Nuclear Plant (FNP) Independent Spent Fuel Storage Installation (ISFSI) in accordance with the general license provisions of 10 CFR 72.210 and performs dry storage activities under CoC 1014. On August 25, 2016, SNC completed a revision to the FNP 10 CFR 72.212 report which applied the changes authorized by the revised certificate. Accordingly, SNC is providing the following registration information for casks loaded previously under CoC 1014, Amendment 9 in order to re-register these casks under CoC 1014, 9R1.
