SUBJECT: GE OIL & GAS' RESPONSE TO THE U.S. NUCLEAR REGULATORY  
COMMISSION INSPECTION REPORT NO. 99901468/2016-201, AND NOTICE  
OF NONCONFORMANCE

Dear Ms. Sullivan:

Thank you for your August 15, 2016, letter in response to the Notice of Nonconformance (NON) that was discussed in the subject U.S. Nuclear Regulatory Commission (NRC) inspection report.

We have reviewed your letter and found that it is not fully responsive in addressing NON 99901468/2016-201-01. Your response to NON 99901468/2016-201-01 discussed several completed and planned corrective actions, but does not address the apparent GE Oil & Gas failures to:

1. Verify the tensile strength property as it related to the spindle material ASTM B637 Type 2 (Inconel) cited as specific example in the NON.
2. Justify the lack of verification of the tensile strength property as it related to other non-stainless steel products previously manufactured and shipped.

Please describe the actions GE Oil & Gas has taken to verify the tensile strength property for the ASTM B637 Type 2 spindles, the actions GE Oil & Gas plans to take to verify the tensile strength properties for future orders, and the justification for previously manufactured and shipped safety-related components made from ASTM B637 or other non-stainless steels.

Please provide a written explanation or statement within 30 days of this letter in accordance with the instructions specified in the subject inspection report NON. The agency will consider extending the response time if you show good cause for us to do so.
