It has come to our attention that Peabody Midwest Mining, LLC (Bear Run Mine), NRC License 13-15133-05 has filed for bankruptcy. (h)(1) Each general licensee that is required to register by § 31.5(c)(13) of this chapter and each specific licensee shall notify the appropriate NRC Regional Administrator, in writing, immediately following the filing of a voluntary or involuntary petition for bankruptcy under any chapter of title 11 (Bankruptcy) of the United States Code by or against
