PPL Bell Bend, LLC (now Bell Bend, LLC) submitted a Combined License (COL) application for the Bell Bend Nuclear Power Plant (BBNPP) via Reference 1. The safety review associated with the application was suspended (Reference 2) due to a lack of progress on the U.S. EPR Design Certification Application, which was subsequently suspended as well (Reference 3). The Final Environmental Impact Statement associated with the BBNPP COLA was issued earlier this year (Reference 4).

The purpose of this letter is to inform the NRC that, in accordance with 10 CFR §2.107, Bell Bend, LLC hereby withdraws the BBNPP COL application in its entirety.
