On August 25, 2016, the U.S. Nuclear Regulatory Commission (NRC) completed a security baseline inspection at your H. B. Robinson Steam Electric Plant, Unit 2. The inspection covered one or more of the key attributes of the security cornerstone of the NRC's Reactor Oversight Process. The enclosed inspection report (IR) documents the inspection results that were discussed on Aug 25, 2016, with Mr. R. Glover and members of your staff.

No NRC-identified or self-revealing findings were identified during this inspection.
