

1) Exercise Option Year Two (2) in the amount of \$111,395.40, thereby increasing the ceiling amount from \$222,169.30 to \$333,864.70; and extending the period of performance through 09/25/2017. The period of performance is hereby changed to reflect the correct start date of 9/26/2014 and end date of 9/25/2017.

2) Correct the STAQS base and exercised options (ceiling) amount to accurately reflect the amounts in the task order.- The previous ceiling amount of \$804,301.25 incorrectly included all options. This has now been decreased by \$470,436.55, from \$804,301.25 to \$333,864.70 to Continued ...
