On August 8, 2016, the U.S. Nuclear Regulatory Commission (NRC) cited Troy Curnutt Consulting for a violation involving the performance of commercial leak testing activities, which was not an activity authorized under NRC byproduct material license 11-35248-01. Inspection Report 030-38843/2016-001 with enclosed Notice of Violation (ML16221A681), required you to respond in writing in 30 days. You responded by letter received on September 1, 2016 (ML16250A422), which referenced your amendment request dated August 29, 2016 (ML16245A799).

After reviewing the information you provided in your response to the Notice of Violation, we have concluded that your completed and proposed actions appear to adequately address the regulatory noncompliance described in the Notice of Violation. We will review your implementation of these corrective actions during a future inspection to determine whether full compliance has been restored and whether compliance will be maintained. Your amendment request dated August 29, 2016, is under review by the NRC staff and you will be notified in a separate correspondence regarding this matter.
