SUBJECT: THE ROSS IN SITU URANIUM RECOVERY PROJECT: DETERMINATIONS OF ELIGIBILITY FOR TWELVE CULTURAL PROPERTIES (48CK2216, 48CK2217, 48CK2223, 48CK2224, 48CK2070, 48CK2076, 48CK2080, 48CK2087, 48CK2089, 48CK2090, 48CK2230, AND 48CK2231)

Dear Ms. Hopkins:

The U.S. Nuclear Regulatory Commission (NRC) is submitting for your review and concurrence on the enclosed determinations of eligibility for 12 cultural properties to the National Register of Historic Places (NRHP). The 12 cultural properties include four with tribal religious and cultural significance (48CK2216, 48CK2217, 48CK2223, and 48CK2224), seven with archaeological features (48CK2070, 48CK2076, 48CK2080, 48CK2087, 48CK2089, 48CK2090), and one isolate (48CK2230). Updated cultural properties forms are provided as an enclosure to this letter.

The four cultural properties with tribal religious and cultural significance were originally identified during the two tribal field surveys conducted within the Ross Project area in May and June of 2013. These survey efforts were conducted by representatives of the Cheyenne and Arapaho Tribes of Oklahoma, the Crow Creek Sioux Tribe, the Eastern Shoshone Tribe, the Fort Belknap Indian Community, the Northern Arapaho Tribe, the Northern Cheyenne Tribe, the Rosebud Sioux Tribe, the Santee Sioux Tribe, the Turtle Mountain Band of Chippewa Indians, and the Yankton Sioux Tribe. As a result of these surveys, the Tribes: (a) identified and recorded 18 cultural properties with tribal religious and cultural significance within the 1,721-acre Ross Project area; (b) made recommendations regarding the properties' NRHP eligibility; (c) provided a preliminary identification of potential Ross Project effects to those cultural properties; and (d) made preliminary recommendations for adverse effects mitigation strategies. These survey results were incorporated into the "Tribal Field Surveys in the Ross Project Area" report, dated November 12, 2014, that described these 18 cultural properties identified during the tribal field surveys. Only these four cultural properties out of the 18 identified were unevaluated for listing in the NRHP.

In an effort to gather additional information regarding the NRHP eligibility of these four cultural properties, the NRC sent a request for additional information, by letter dated April 27, 2016, to the Programmatic Agreement (PA) Parties (Signatories, Invited Signatories, and Consulting Tribes). Following that letter, the NRC staff held conference calls open to all PA Parties (May 2, 2016 and June 7, 2016) and separate calls with tribal members and Bureau of Land Management (BLM) (May 2, 2016, May 12, 2016, and May 25, 2016) to discuss the NRHP eligibility for the four unevaluated cultural properties. The NRC received one written response. On July 15, 2016, the NRC staff sent its draft eligibility determinations to the PA Parties for a 30 day review. In response to that letter, additional information was provided to the NRC to support an eligible determination from the Northern Arapaho Tribes Tribal Historic Preservation Officer (THPO) and the BLM Newcastle Field Office. These two responses are enclosed with this letter.

The remaining eight cultural properties are seven archeological properties and one isolate. Six of the seven archaeological properties were originally identified during a Class III survey performed in 2010 and revisited during the tribal field surveys performed in 2013. The remaining property and the isolate (48CK2230 and 48CK2231) were originally identified during the tribal field surveys. After the tribal surveys, additional site visits were performed to locate artifacts and features identified during the previous studies and to gather additional information. During the spring of 2016, the NRC and BLM had multiple conversations to discuss the eligibility of these properties.

Based on the information gathered, the NRC evaluated the 12 cultural properties for listing in the NRHP, using all four eligibility criteria. Five of the cultural properties evaluated were previously found eligible under Criterion A as noted in the Summary Table below. Below is a summary of the NRC determinations for these sites.
