SUBJECT: NOTIFICATION OF REDUCED SUPPORT FOR MULTIPLE INTEGRATED LASER

ENGAGEMENT SYSTEM DURING NRC-EVALUATED FORCE-ON-FORCE

EXERCISES

Dear Mr. Toben:

The U.S. Nuclear Regulatory Commission (NRC) has examined several initiatives to reduce costs associated with the NRC-evaluated force-on-force (FOF) inspection program, while maintaining the overall effectiveness of the inspections. These initiatives were conducted under the NRC's Project AIM efforts. One cost reduction is associated with the level of support from the NRC-contracted Multiple Integrated Laser Engagement System (MILES) support trailer (currently contracted as Eagle Research Group). NRC will be reducing the number of days the MILES support trailer will be on-site for the preparation week activities. Specifically, the MILES support trailer would arrive at the licensee site on the Thursday of the week before the NRC-evaluated FOF exercise week, as opposed to the current Sunday arrival. We are planning to implement this reduction for the FOF Inspection Cycle 5, in January 2017.

The NRC-contracted MILES support trailer provides all of the MILES equipment (i.e., responder exercise weapons, Composite Adversary Force exercise weapons and equipment, MILES halo and harnesses with additional equipment) normally provided during NRC-evaluated FOF exercises. This equipment is currently used by the licensee for preparatory exercises before the NRC inspection. These preparation activities will be affected by this reduction effort. Licensees should coordinate with MILES support trailer personnel to outfit responder exercise weapons with licensee-provided sighting optics, weapons slings, and to familiarize the responder exercise players and player controllers with the NRC-provided MILES equipment.

Licensees should also coordinate with NRC-contracted MILES support trailer personnel to ensure that the MILES issue and return area is appropriate for safety and security and reflects the licensee process conducted during annual licensee-conducted exercises.
