The following additional information is needed to review your request.

1. Your NRC license authorizes you for 9 Troxler moisture/density (m/d) gauges, however, your transfer records shows only 6 m/d gauges were transferred. Please verify how many Troxler m/d you possessed under your NRC license and the radionuclides used in these gauges. For example, we only possessed and used 6 Troxler moisture/density gauges containing sealed americium-241 and cesium-137 sources.
2. Please provide a copy of the radioactive materials license for the Troxler – Chicago Office where your Troxler m/d gauges were transferred on 8/15/2016.
3. Please provide a copy of the leak test results that were current when your 6 Troxler m/d gauges were transferred to the Troxler-Chicago Office on 8/15/2016.

Please include a cover letter on company letterhead, dated and signed (signed by an individual who is authorized to sign official documents on behalf of the licensee) with your response letter.
