SUBJECT: SUMMARY OF AUGUST 17, 2016, MEETING WITH THE AREVA INC.

Background

A meeting was held on August 17, 2016, in Rockville, Maryland, between the U.S. Nuclear Regulatory Commission (NRC) and AREVA Inc. (AREVA) to discuss proposed Amendment No. 15 to Certificate of Compliance No. 1004, for the Model No. Model No. Standardized NUHOMS® storage system.

The meeting was noticed on July 7, 2016 (see Agencywide Documents Access and Management System (ADAMS) Accession No. ML16189A346). The meeting attendance list is provided as Enclosure No. 1, the non-proprietary presentation slides are provided in Enclosure No. 2, the proprietary presentation slides are provided in Enclosure No. 3.

Discussion

The proposed amendment will include items generic to all NUHOMS® systems and items specific to the NUHOMS®-32PTH1, -32PT, and the -61BTH storage casks. The scope of the amendment for all NUHOMS® systems include four items: requirements for solar shield, rain shield during transfer operations, simplification of fuel qualification tables, characterization of control components, and expanded cladding materials. For the NUHOMS®-32PT amendment will address up to 16 damaged fuel assemblies, include PRAs in Type A1 and Type A2 baskets and add fuel qualification tables for reduced uranium loading. For the NUHOMS®-32PTH1, the amendment will add new heat load zoning configurations (without and increase to the total heat load for the system), and add fuel qualification tables for reduced uranium loading (similar to Amendment 14). For the NUHOMS®-61BTH, the amendment will include new fuel types/ and separate enrichment limits for damaged fuel assemblies with channels.

During the proprietary discussion, AREVA added further details on items, including the proposed heat zone loading, methodology for evaluating damaged fuel, and inclusion of alternative poison rod assemblies.
