3. All documents related to or discussing the total cost of, and/or budget details for, the study, including both any outside contractor costs and NRC Staff costs;



5. All documents related to or containing any comments by NRC Staff members as part of the peer review, or NRC Staff comments in additional to the peer review; and
6. All communications between any member of NRC Staff with other members of NRC Staff, or with any non-NRC contractor.
