**ORDER**

Edlow International Company (Edlow) submitted a motion on August 31, 2016, seeking an extension of time until October 4, 2016, to file an answer to Dr. Alan J. Kuperman's intervention petition on Edlow's application to export highly enriched uranium to the BR-2 research reactor in Belgium. On September 6, 2016, I issued an order granting Dr. Kuperman seven days to respond to Edlow's extension request in writing and issuing a housekeeping stay to enable full consideration of Edlow's motion.<sup>1</sup> On September 9, 2016, Dr. Kuperman filed a written response opposing Edlow's request for an extension of time.

After reviewing the motion and response, I deny Edlow's motion for an extension of time, terminate the housekeeping stay, and set a new deadline three business days from the date of this order for Edlow to submit an answer to Dr. Kuperman's petition to intervene. Pursuant to 10 C.F.R. § 110.83(b), Dr. Kuperman may file a reply to Edlow's answer within ten days after Edlow's answer is filed.

This Order is issued under my authority in 10 C.F.R. § 110.88.
