**14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)**

The purpose of this modification is to  
 1) Exercise Option Year One (1) in the amount of \$5,116.15 thereby increasing the exercised ceiling amount from \$4,845.36 to \$9,961.51. and extending the period of performance through 09/16/2017. This exercise of option is being fully funded, thereby increasing obligations in the amount of \$5,116.15 from \$4,845.36 to \$9,961.51.

2) Correct the STAQS Base and All Options (total contract value) amount, in which the previous contracting specialist inadvertently left out option years 1 (\$5,116.15) and 2 (\$5,320.80). The Base and all options value is corrected, increasing in the amount of \$10,436.95 from \$4,845.36 to \$15,282.31. The STAQS amounts now correctly reflects what was intended in the awarded contract.
