**Pre-licensing Meeting with Duke Energy**

On August 30, 2016, the staff met with representatives of Duke Energy to hold a pre-licensing meeting at NRC Headquarters in Rockville, Maryland, to discuss the licensee's plan to submit license amendment requests to change Technical Specification 3.8.1, "AC Sources –Operating," to modify Required Action B.4 to extend the Completion Time (CT) of an inoperable emergency diesel generator (EDG) at the Catawba Nuclear Station, Units 1 and 2, and McGuire Nuclear Station, Units 1 and 2. The proposed amendment would extend the CT from 72 hours to 14 days for one inoperable EDG. The licensee plans to submit the proposed amendments to the NRC in February 2017.
