The purpose of this letter is to confirm the final arrangements for the upcoming licensing examinations at Surry Power Station.

The U.S. Nuclear Regulatory Commission (NRC) has completed its review of the operator license applications submitted in connection with this examination and separately provided a list of approved applicants to your office. The U.S. Nuclear Regulatory Commission (NRC) has approved the subject examinations and NRC staff will administer the operating tests during the week of September 19, 2016. You may administer the written examinations in accordance with Revision 10, of NUREG-1021, "Operator Licensing Examination Standards for Power Reactors," during the week of September 26, 2016.

This examination has undergone extensive review by my staff and representatives responsible for operator training at your facility. Based on this review, I have concluded that the examination meets the guidelines of NUREG-1021 for content, operational, and discrimination validity. By administering this examination, you also agree that it meets NUREG-1021 guidelines, and is appropriate for measuring the qualifications of licensed operators at your facility.
