We request for NRC consent to Transfer control as previously requested from our Radiation Safety Officer (reference CN591619 & CN591620).

We request a merging of two USNRC material licenses. We request to add the location of 46591 Romeo Plank Diagnostic Center, [REDACTED] Macomb, Mi 48044 to our 21-03210-01 license. The 6591 Romeo Plank Road, [REDACTED] Macomb, Mi 48044 location is currently under the license # 21-26338-01, which is due to expire November 21, 2016. We also have requested the termination of license #21-26338-01 for 6591 Romeo Plank Road, [REDACTED] Macomb, Mi 48044 is attached and requested to be processed simultaneously so the termination and amendment will allow seamless and continuous use of licensed radioactive materials at our location at 6591 Romeo Plank Road, [REDACTED] Macomb, Mi 48044. We will follow all regulations as required under our license #21-03210-01 at all our facilities including for 6591 Romeo Plank Road, [REDACTED] Macomb, Mi 48044.

To clarify our current business relationship between the two locations/licensees is the St. John Romeo Plank Diagnostic Center Nuclear Department is considered a actual department of St. John Hospital & Medical Center since January 2014. Our past history of the Romeo Plank Diagnostic Center can be confirmed as an affiliation starting in 1997 as a Cornerstone Health Services site, prior to that this was a stand along non-affiliated site. In 2000 Cornerstone, now called Cornerstone MRG, became loosely associated with St John Hospital. In January 2012 the Diagnostic Center gradually coordinated services with St John Hospital & Medical Center.
