By letter dated August 31, 1989 I submitted a proposed amendment to the Oconee Nuclear Station (ONS) facility operating licenses and revisions to the ONS Technical Specifications regarding auxiliary electrical systems. On January 9 and 10, 1990 members of my staff met with the NRC staff to discuss the proposed amendment. As a result, please find attached (Attachment 1) a supplement to the August 31, 1989 amendment request. This supplement supersedes the August 31, 1989 request in its entirety, however the Technical Justification and no significant hazards consideration evaluation remain valid. Technical justification for this supplement is provided in Attachment 2.
