EFW Initiation Proposed Technical Specifications

Gentlemen:

Pursuant to 10 CFR 50.90, please find attached (Attachment 1) a proposed amendment to the Oconee Nuclear Station (ONS) Facility Operating Licenses and revisions to the ONS Technical Specifications. Specifically, Technical Specification 3.4 is revised to address the need to bypass automatic initiation of the Emergency Feedwater (EFW) system when turbine header pressure is below 800 psig in order to prevent inadvertent actuation. This proposed amendment is in response to Inspector Followup Item 90-30-02 in NRC Inspection Report 50-269, -270, -287/90-30, which determined that the existing Technical Specifications regarding initiation circuitry for the EFW System were inadequate. Attachment 2 provides revised Bases which support changes to Technical Specifications.

I have determined that the proposed amendment involves no significant hazards considerations. Attachment 4 provides the No Significant Hazards Consideration Evaluation. Attachment 3 provides the Supporting Technical Justification.

I am forwarding a copy of this application to the South Carolina Department of Health and Environmental Control for review and, as appropriate, subsequent consultation with the staff.
