Remove List of Containment Penetrations

Attached is a proposed amendment to the Oconee Nuclear Station (ONS) facility operating licenses and revisions to the ONS Technical Specifications, pursuant to 10 CFR 50.90. The proposed amendment would delete Table 4.4-1, List of Penetrations with 10 CFR 50, Appendix J Test Requirements, from the Technical Specifications. The list of penetrations would then be relocated to the Selected Licensee Commitments Manual. This would permit administrative control of changes to the list of penetrations without having to process a license amendment. This change is needed to eliminate an unnecessary burden on NRC and Duke Power resources for processing Technical Specification changes.

Attachment 1 shows the proposed amendment and associated Bases changes. Attachment 2 provides a marked-up version of the proposed Technical Specification changes.

Attachment 3 provides technical justification for the proposed amendment, which is based on the guidance in Generic Letter 91-08. As required by 10 CFR 50.91, Attachment 4 provides our analysis about the issue of No Significant Hazards Consideration based on the standards in 10 CFR 50.92.

I am forwarding a copy of this application for amendment to the South Carolina Department of Health and Environmental Control (DHEC) for review and subsequent consultation with the NRC staff.




