SUBJECT: SUMMARY OF A PUBLIC MEETING WITH SOUTHERN NUCLEAR  
OPERATING COMPANY AND SOUTH CAROLINA ELECTRIC & GAS  
ON AUGUST 25, 2016

The U.S. Nuclear Regulatory Commission (NRC) staff held a Category 2 public meeting with Southern Nuclear Operating Company (SNC) and South Carolina Electric & Gas (SCE&G) on August 25, 2016. The purpose of the meeting was to discuss issues associated with the safety review of licensing actions for SNC's Vogtle Electric Generating Plant (VEGP) Units 3 and 4, and SCE&G's Virgil C. Summer Nuclear Station (VCSNS) Units 2 and 3.

Summary of Meeting:

On August 25, 2016, staff from the NRC conducted a public meeting with representatives from SNC and SCE&G to discuss issues associated with the safety review of licensing actions for SNC's VEGP Units 3 and 4, and SCE&G's VCSNS Units 2 and 3. Specifically, the meeting discussed (1) draft RAI for SG to RCP weld American Society of Mechanical Engineers (ASME) alternative request and (2) SNC and SCE&G LARs 16-009R2 and 14-14R2, respectively, requesting changes to the structural design of the AP1000 auxiliary building floors.

The first topic discussed was the draft RAI regarding the licensee's requests for alternative pre-service inspection requirements for SG nozzle to RCP casing welds. The licensees asked clarification questions regarding the draft RAI to understand the staff's requests. In response to Question 1, the licensees stated that a summary of the fracture mechanics analysis could be provided, including the analysis of postulated vibrations of the SG and RCP. Additionally, the licensees stated that if a full calculation audit of the analysis is needed, it can be supported. The staff noted that, due to the licensee's requested approval date for this alternative request, if their responses provide detailed information to address the staff's requests, an audit may not be necessary to make the required finding.

The second topic discussed was SNC LAR 16-009R2 and SCE&G LAR 14-14R2 requesting changes to the structural design of the AP1000 auxiliary building floors. The staff provided comments on the LAR addressing clarifications and requesting additional information be provided in support of the LAR. Regarding Change Activity 4, the staff asked if the change impacts fire protection or main control room habitability. The licensees noted that the fire protection programs are not changed by this LAR and noted that they would provide additional clarifications. The staff asked the licensees to provide an example of the demand verses capacity for the most severe (most limiting) loading condition for both the finned floors and the CA20 floors. The licensees noted that they would prepare a supplement to the LAR to address all of the staff comments, including revisions to the Updated Final Safety Analysis Report markups to provide clearer descriptions in the text, Table 3H.5-13, and several figures.

At the end of each topic discussed, there was an opportunity for the public to provide comments and ask questions. All comments and questions were addressed before moving to the next topic or ending the meeting.
