Dear Dr. Dobben:

Enclosed is Amendment No. 47 to your NRC Material License No. 13-13144-02 in accordance with your August 25, 2016 request to add two new Authorized Users (AUs) listed on other radioactive materials licenses, with the exception of including a Title 10 of the *Code of Federal Regulations* Section 35.200 authorization for Michael Flisak, M.D. Please note that we have also deleted Condition No. 13 in accordance with current NRC policy to include the reference to Title 10 of the *Code of Federal Regulations*, Part 71, "Packaging and Transportation of Radioactive Material," in the preamble, on page 1 of the license. Finally, we have updated the license format and Condition Nos. 11 and 12.A. in accordance with current NRC licensing practice.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

As discussed via a September 22, 2016 phone conversation with your designated contact person and Nuclear Medicine Supervisor, Ms. Amy Johns Carter, CNMT, we were unable to include a 10 CFR 35.200 authorization for Dr. Flisak because the reference license contained in the application – Amendment No. 57 to Lic. No. IL-01289-01 – indicated that Dr. Flisak's authorizations were limited to 10 CFR 35.100 and 35.300. Additional documentation supporting Dr. Flisak's authorization is needed concerning the 10 CFR 35.200 request.


