South Carolina Electric & Gas (SCE&G), acting on behalf of itself and the South Carolina Public Service Authority (Santee Cooper), the licensees for VCSNS Units 2 and 3, provides this notification in accordance with license condition 2.D(12)(b) of the combined licenses listed in Reference 1.

The license condition requires SCE&G to "complete the analysis of the as-designed individual piping segments and shall inform the Director of NRO, or the Director's designee, in writing, upon the completion of these analyses and the availability of the design reports for the selected piping packages."

The purpose of this letter is to notify the Nuclear Regulatory Commission (NRC) that the analysis for this portion of selected packages identified in AP1000 DCD, Rev. 19, Section 3.9.8.7, is complete and available for NRC inspection:

- APP-RCS-PLR-030, ADS 4th Stage East Compartment
- APP-PXS-PLR-030, ADS 4th Stage West Compartment and PRHR Supply
- APP-PXS-PLR-040, PRHR Return Line
- APP-CVS-PLR-100, CVS Letdown from Penetration 002 IRC 2
