SUBJECT: REQUEST FOR WITHHOLDING INFORMATION FROM PUBLIC  
DISCLOSURE THE SEPTEMBER 30, 2016, MITSUBISHI ELECTRIC  
SUBMISSION (TAC NO. MF4228)

Dear Mr. Remley:

By letter dated September 30, 2016 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML16274A003), Mitsubishi Electric Corporation (MELCO) submitted an affidavit dated September 30, 2016, executed by Shigeru Sugitani, Senior Manager, Control & Protection Systems Section (ADAMS Accession No. ML16274A004). In the affidavit, MELCO requested that the information contained in the following be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390. Also, in an October 25, 2016 call, MELCO stated that the information that was requested to be proprietary was related to its business planning and could provide competitors with insights to MELCO production activities.

JEXU-1041-2099-P R1, "Schedule for Providing the Response to the  
Request for Additional Information"

MELCO stated that it did not plan to submit nonproprietary versions of the document. The basis given was that, because of the extensive amount of proprietary information in the document, nonproprietary versions would be of no value to the public.

MELCO detailed the reasons for withholding the information the affidavit.

The U.S. Nuclear Regulatory Commission (NRC) staff has reviewed your application and the material in accordance with the requirements of 10 CFR 2.390. On the basis of the statements in the affidavit, the NRC staff has determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure.

Therefore, the version of the submitted information marked as proprietary will be withheld from public disclosure under 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.
