Dear Mr. Hanley:

By letter dated September 26, 2016 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML16273A474), the Electric Power Research Institute (EPRI) provided a September 12, 2016, letter with an affidavit executed by Mr. Neil Wilmshurst also dated September 12, 2016. The affidavit requested that the information contained in the following document be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390:

"BWRVIP-25, Revision 1: BWR Vessel and Internals Project, BWR Core Plate
Inspection and Flaw Evaluation Guidelines"

A nonproprietary copy of this document has been placed in the U.S. Nuclear Regulatory Commission's (NRC's) Public Document Room and added to the NRC Library in ADAMS as Accession No. ML16273A475.

The reasons for requesting withholding of the report are provided in the affidavit.
