The purpose of this modification is to 1) exercise the Option to Extend Services for 6 months, thus extending the period of performance end date from 11/30/2016 to 05/31/2017; 2) increase the ceiling value amount by \$755,936.10, from \$9,790,000.00 to \$10,545,936.10; and 3) provide incremental funding in the amount of \$244,067.77, thereby increasing the total obligated amount from \$9,698,799.34 to \$9,942,867.11.
