SUBJECT: RESPONSE TO NRC INSPECTION REPORT 040-08502/2016-001
AND NOTICE OF VIOLATION

Dear Mr. Kruse:

On August 26, 2016, the U.S. Nuclear Regulatory Commission (NRC) cited Uranium One USA, Inc. for its failure to maintain a bleed (continuous pumping of groundwater) in each individual wellfield as required by the license. The NRC Notice of Violation (Agencywide Documents Access Management System [ADAMS] Accession Number ML16243A088) required you to respond in writing within 30 days. Mr. Scott Schierman, HSE Manager and Radiation Safety Officer, responded to the Notice of Violation by letter dated September 26, 2016 (ML16272A129).

After reviewing the information provided in your response to the Notice of Violation, we have concluded that your completed and proposed actions appear to adequately address the regulatory noncompliance as described in the Notice of Violation. We will review your implementation of these corrective actions during a future inspection to determine whether full compliance has been restored and whether compliance will be maintained.

In accordance with 10 CFR 2.390 of the NRC's "Agency Rules of Practice and Procedure," a copy of this letter will be made available electronically for public inspection in the NRC Public Document Room or from the NRC's ADAMS, accessible from the NRC Web site at <http://www.nrc.gov/reading-rm/adams.html>.
