By letter dated August 23, 2016, you submitted an application for Certificate of Compliance (CoC) No. 9374, Revision No. 0, for the Model No. HI-STAR 80 package. The staff performed an acceptance review of your application to determine if it contained sufficient technical information in scope and depth to allow the staff to complete a detailed technical review.

This letter is to advise you that, based on our acceptance review, the application does not contain sufficient technical information. The information needed to continue our review is described as a request for supplemental information (RSI) in the enclosure to this letter. Please note that addressing these RSIs does not preclude the staff from issuing further requests for additional information (RAIs) during the course of the detailed technical review.

In order to schedule our technical review, the RSI responses should be provided by October 20, 2016. If the RSI responses are not received by this date, the application may not be accepted for review, and the staff may discontinue any further review. If the RSI responses are deemed acceptable, we estimate that we will need approximately 2,500 hours to complete the technical review prior to the CoC issuance.
