This letter forwards NRC Form 591, "Safety Inspection," indicating that no items of non-compliance were found during the above described inspection of your licensed activities. Please retain the form in your files. During the previous inspection, you received five violations of NRC requirements. Corrective Actions for four of the violations were evaluated and determined to be adequate. The violation for failure to conduct adequate DOT Hazmat employee training could not be evaluated because this training occurs every three years and has not yet been administered. The corrective actions for this violation will be reviewed at the next inspection.
